ORDER:

In the G.O. 1st read above, the Government have issued orders for the Establishment, Registration, Recognition, Administration and Control of all Categories of Schools under all Categories of Managements under the provisions of the Telangana Education Act, 1982 (Act 1 of 1982).

- 2. In the G.O. 2nd read above, orders were issued delinking the Private Management Schools from the Local Body Schools (M.P., Z.P. Schools and Municipal Schools).
- 3. In the G.O.3rd read above, Government have accorded permanent Recognition to all the Local Body Schools managed by the Mandal Parishad, Zilla Parishad and Municipal Schools on par with the Government Schools.
- 4. In the reference 6th read above, the Director of School Education has submitted that as per Section 6 of the Right of Children to Free and Compulsory Education Act, 2009 (Act 35/2009) it is the responsibility of the State Government / Local Authority to establish Schools in all neighbourhoods. Hence, he has proposed to exempt the Application Fee prescribed under Rule 5(C) of the Telangana Educational Institutions (Establishment, Recognition, Administration and Control of Schools) Rules, 1988 for considering a proposal for Establishment/ Up-gradation of a School in a locality based on need.
- 5. Government after careful examination, hereby accept the proposal submitted by the Director of School Education, TS., Hyderabad in the reference 6th read above.
- 6. The above orders shall come into force with immediate effect.
- 7. The Director of School Education, T.S., Hyderabad shall take appropriate action in the matter immediately.
- 8. Accordingly, the following Notification will be published in an Extra-Ordinary issue of the Telangana Gazette dated 14.07.2016.
