O R D E R:-

In the G.O. first read above, an adhoc rule was issued to fill-up the backlog vacancies of Scheduled Castes and Scheduled Tribes duly waiving the written examination and interview so as to fill up the identified backlog vacancies in the united State of Andhra Pradesh. The time limit is being extended from time to time, to fill up the backlog vacancies of Scheduled Castes and Scheduled Tribes upto 30.06.2014.

After formation of Telangana State, Government have decided to extend the time limit for filling up the backlog vacancies of Scheduled Castes and Scheduled Tribes as on 31.12.2012 for a further period upto 30.06.2016 in Telangana State.

To fill up the backlog vacancies in Group-IV services under the purview of District Selection Committees, orders were issued in G.O. 2<sup>nd</sup> read above. To extend the time limit for filling up the backlog vacancies, the following amendment is issued to G.O.Ms.No.215, G.A.(Ser.A)Deptt., dt:08.05.2001 and as subsequently amended from time to time.

**NOTIFICATION**

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and of all other powers hereunto enabling, the Governor of Telangana hereby makes the following amendment to the Adhoc Rules issued in G.O.Ms.No.215, General Administration (Ser.A) Department, dated the 8<sup>th</sup> May, 2001 and as subsequently amended from time to time.
